Notice is given in accordance with School Standards and Organisation (Wales) Act 2013 and the School Organisation Code, Merthyr Tydfil County Borough Council, having consulted with such persons as required, proposes to establish a new Welsh Medium Learning Resource Base (LRB) located within Ysgol Gymraeg Rhyd Y Grug, Aberfan, Merthyr Tydfil, CF48 4NT.

The new Learning Resource Base will be a generic 12 place Welsh Medium provision for pupils aged between Reception and Year 6 with Additional Learning Needs (ALN). The LRB will accommodate pupils with ALN requiring a specialist class placement and cater for a range of different needs including but not limited to Autism Spectrum Disorder (ASD) and Complex Needs. It is proposed to implement this proposal on 01st September 2025.

Places in the LRB will be available to pupils across Merthyr Tydfil and will not be limited to the catchment of Ysgol Gymraeg Rhyd Y Grug. Pupil admission to the LRB will be managed by the local authority's ALN Panel based on evidence and assessment of need following appropriate referral to the ALN Team.

Home to school transport will be provided for children who are allocated a place in the LRB by the ALN Panel if either: i. The distance from home to school is at least 2 miles, or ii. The distance from home to school is less than 2 miles but the pupil has been assessed by ALN panel as being unable to walk to school due to their SEN, disability and/or medical condition.

The Council undertook a period of consultation before deciding to publish this proposal. A consultation report, containing a summary of the issues raised by consultees and the proposer's response and the views of Estyn, is available on the Merthyr Tydfil County Council website at:
