**The Local Authorities
(Referendums) (Petitions and
Directions) (Amendment) (Wales)
Regulations 2003
(The “Regulations”)**

Under the provisions of the Local Government Act 2000 (the “Act”) the Council is able to arrange for the discharge of its functions in a specified form defined in Sections 11(2) to (4) of the Act or in Regulations made under Section 11(5).

The Regulations also provide that the Council may be petitioned to hold such a referendum on whether the Council should operate executive arrangements involving a form of executive for which a referendum is required if at least 10% of the Local Government electors in the authority’s area require it. The Council has to publish a statement of what figure represents 10% of the electorate.

NOTICE IS HEREBY GIVEN that the number of electors (The Verification Number) representing 10% of the registered electors in the Merthyr Tydfil County Borough Council is **4,677**

The rules for the presentation of a petition are contained in the Regulations shown at the head of this Notice. However, the petition period is six months and commences on the 6 May 2026 until 6 November 2026.
