Interested in becoming a local Councillor?

WHAT A COUNCILLOR DOES...

- A Councillor's role can include:Representing your local ward
 - Decision making
- Policy and strategy review and development
- Regulatory duties
- Community leadership and engagement
- Overview and scrutiny
- How much do I need to know?

The main qualifications are an interest in your local community and a willingness to learn. Once elected you will be offered a comprehensive induction to your role as a Councillor and will receive ongoing support, guidance and training.

To help you carry out your duties you will also have access to the Democratic Services team as well as advice from other professional officers of the council.

What expenses can I claim if I become a Councillor? Councillors receive an annual basic salary and certain approved duties are eligible for travel and/or subsistence allowances. Some Councillors also receive a senior salary for particular duties they undertake (for example, chairing a committee). In certain circumstances, an allowance is available for expenses arranging the care of children or dependents while undertaking official business as a Councillor.

IN ORDER TO BE ELIGIBLE TO BECOME A CANDIDATE...

You MUST be:

- at least 18 years old
- a British citizen, an eligible Commonwealth citizen or a citizen of any other member state of the European union; and
- meet at least one of the following four qualifications:
- (1) you are, and will continue to be, registered as a local government elector for the local authority area in which you wish to stand from the day of your nomination onwards
- (2) you have occupied as owner or tenant any land or other premises on the local authority area during the whole of the 12 months before the day of your nomination and the day of election
- (3) your main or only place of work during the 12 months prior to the day of your nomination and the day of election has been in the local area
- (4) you have lived in the local authority area during the whole of the 12 months before the day of your nomination and the day of election.

You CANNOT stand as a candidate if

- you are employed by the local authority or hold a paid office under the authority (including joint boards or committees)
- you hold a politically restricted post
- you are the subject of a bankruptcy restrictions order or interim order
- you have been sentenced to a term of imprisonment of three months or more (including a suspended sentence), without the option of a fine, during the five years before polling day.
- you have been disqualified under the Representation of People Act 1983 (which covers corrupt and illegal electoral practices and offences relating to donations) or under the Audit Commission Act 1998.

If you are thinking of STANDING FOR ELECTION and wish to discuss it with the local authority please contact Democratic Services who will be happy to provide advice on the rules around submitting nomination papers and campaigning.

We are also hosting an event led by the Welsh Government aiming to increase the diversity of individuals standing for election to local government. It's being held on Thursday 16th February 2017 at 6pm at the Civic Centre and anyone interested in standing as a local Councillor is welcome to come along.



The locations winning the bid included popular tourist attraction Cyfarthfa Castle, Park, Ironworks and Viaduct, Gurnos Tramroad and Leat, Morlais Quarry, Taff Trail, Parc Taf Bargoed, Taf Fechan Nature Reserve, Pontsticill and Brecon Mountain Railway.

DECLARATION OF AIR QUALITY MANAGEMENT AREA IN TWYNYRODYN

An Air Quality Management Area (AQMA) will shortly be declared in Twynyrodyn to cover properties in Twynyrodyn from Davies Terrace up to Gilfach Cynon.

The air quality in the County Borough is regularly monitored by the Council and is generally

Vintage tearooms is the latest Merthyr Tydfil

'Meanwhile' launch

A unique support scheme helping Merthyr Tydfil entrepreneurs showcase their goods and services on the High Street has seen the launch of the town centre's first vintage tearooms.

Lunah Tearooms has opened at what was once Flooks jeweller's shop and will be the venue for the next six months for bespoke afternoon and gentlemen's teas, baby showers and children's parties - thanks to the 'Meanwhile' programme run by MTCBC and Merthyr Tydfil Enterprise Centre (MTEC).

Through the scheme - which matches entrepreneurs with vacant buildings and willing landlords - Tearooms owner Catherine Poole has received business and financial planning support from MTEC, with the Council securing a tenancy for her with Merthyr Tydfil Housing Association

Cyfarthfa Park volunteers continue to help transform top attraction

Volunteering work, helping to transform Merthyr Tydfil's most popular tourist attraction is to continue after completion of a major redevelopment programme. Cyfarthfa Park has seen an investment of £3.3m million from the Heritage Lottery Fund (HLF), Welsh Government, CADW and

MTCBC over the past four years. More than 120 local volunteers have contributed over £100,000 worth of their time to the Cyfarthfa Parks for People project, working alongside apprentices and staff from the Council and Merthyr

Tydfil Leisure Trust (MTLT). The team has helped bring back to life disused structures such as the Icehouse, which was used to store foodstuffs, and original features such as the walled kitchen aarden, alasshouses and bugay store. The Bothy – an old shelter now provides accommodation for staff, meeting and classroom facilities, and will shortly house a new shop.

There have also been improvements to Cyfarthfa Ponds, the bandstand, bowls pavilion and tennis courts, enhancement of the

lake and park landscape and the installation of new pathways to improve access.

Merthyr Tydfil Mayor, Councillor Margaret Davies, presented the volunteers with certificates to mark their time on the scheme. "They have worked on landscaping and drainage, grown and sold produce from the park and helped with administration and events," she said.

Council's gritting crews work round-the-clock to ensure that our roads are treated and residents can travel safely.

The crews make sure that the gritters are ready, our salt stocks are high and the salt bins are topped up across the County Borough.

Unfortunately, it's not possible for the gritters to spread grit on every road and pedestrian area, so to overcome this we've provided over 254 grit bins at key locations throughout the County Borough. This year I drove a aritter that was fitted with a snow plough, which extends approximately 2.5m at the front of the vehicle; this gave me a much better understanding of the concentration needed when the vehicles are in operation. Double parked vehicles, narrow streets,

roadworks and youths attacking them with snow balls make an already difficult job even harder. The crews have my full respect and admiration and I'd like to thank them for the work they do to keep our roads safe.'

Bird Boxes installed to help Dipper population

In arctic conditions, waist deep in water, South Wales Fire and Rescue Service installed three bird boxes along the River Taff in Merthyr Tydfil, to help our Dipper population.

Dippers are predominantly under water feeders, they use their wings to walk and swim through the water picking mayflies, caddish fly larvae and small fish (minnows) from the bottom of the river bed. These birds are of RSPB amber status. The UK population is declining due to the health of our rivers, too much pollution from chemical contaminants and diminishing aguatic insect food. The stretch of the River Taff in the town centre is highly modified and does not have as good a habitat for wildlife as much of the rest of the River Taff.

The boxes are directly above the water so the Dippers can fall straight in to the water if predators, such as mink and other large birds attack them.

Thankfully, here in Wales our

population is currently stable, but only if we keep looking after our rivers. A big thank you goes to the Firemen of Merthyr Tydfil Fire and Rescue Service, Welsh Government Directorate for Environment and Sustainable Development grant and Merthyr Tydfil CBC Planning and Countryside Department, for their help in improving the urban river wildlife connectivity in our town centre.

Treharris Boys and Girls Club Sailing the South Coast with the Island Sailing Trust

For the last three years Treharris Boys & Girls Club, in partnership with the Island Sailing Trust, have organised a week's sailing trip along the English South Coast.

On a bleak Sunday afternoon in January we headed to Merthyr Tydfil Football club to watch the second match from a new team - All Together Merthyr F.C. A community venture headed up by Focal Point and Hope Not Hate aimed at using football to bring people together. The club is made up from people from different cultures who live in around Merthyr, and we met Polish, Portuguese, Welsh, Brazilian and Syrian players, all playing in a friendly against Merthyr Supporters FC.

It was a great match and both teams played with style. All Together Merthyr scored an early first goal getting things off to a flying start. Merthyr Supporters came back strong and by half time the score was 2:1 to Merthyr Supporters. In the second half All Together Merthyr worked hard but Merthyr Supporters played strongly ending the game 3:1

After the match we spoke with midfielder Pedro Carvalho, who works at Design and Supply Ltd here in Merthyr Tydfil. Originally from Portugal Pedro sees the team as vital, 'This team is so important, as it's not just one community, it brings people together. We've already got lots of elements to keep us separate – it's good to have something keeping us together, something we all enjoy' He told how the team had grown and how important it was. 'Football is very important, it's a very strong way to connect people. Not many things in the world can connect people as much as football'

"It's all about bringing communities together to share what we have in common – in this case, sport" says Focal Point project consultant Dr Lesley Hodgson. "Jo Cox' words 'We have more in common that unites us than that which divides us' are at the heart of everything the team does".

Focal Point has now joined forces with Merthyr Tydfil Global Village to support the club while they develop. Merthyr Town F.C and the Football Association of Wales are encouraging All Together Merthyr to be involved in the league. So watch this space!

The Head of the International Football Association of Wales, Mark Evans has said 'Merthyr Town FC are delighted to be partners with All Together Merthyr. Their matches at Penydarren Park have been very rewarding as it has provided an excellent opportunity to bring people together in a fun environment and continued to build bridges within the wider community'

NOTICE is hereby given that Merthyr Tydfil County Borough Council in exercise of its powers under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984 ("the Act")(as amended), and all other enabling powers and after consultation with the Chief of Police in accordance with Part III of Schedule 9 of the Act proposes to make the following Order, the general effect of which is described below. The effect of the Order is as follows:-

- 1. No person shall cause any vehicle to wait at any time on the lengths and sides of lengths of road specified in Schedule 1.
- 2. No person shall cause any vehicle to wait for longer than 30 minutes, no return within 1 hour, between the hours of 9am to 5pm, Monday to Saturday (inclusive) on the lengths and sides of lengths of road specified in Schedule 2.
- 3. No person shall cause any vehicle to wait for longer than 3 hours, no return within 1 hour, between the hours of 9am to 5pm, Monday to Saturday (inclusive) on the lengths and sides of lengths of road specified in Schedule 3.
- 4. Vary the Orders specified in Schedule 4.
- 5. Nothing in Articles 1 to 3 shall render it unlawful for emergency service vehicles to wait on the length of roads and sides of lengths of roads specified 'therein'. Vehicles are allowed to wait for the purposes of boarding, alighting, loading and unloading, building and road works, for maintenance, improvement, reconstruction, inspection or survey of the lengths of roads and sides of lengths of roads and the maintenance of essential services, weddings, funerals and the delivery of postal packets by vehicles of the service of the Post Office.
- 6. Nothing in Article 1 shall render it unlawful for disabled persons' vehicles displaying the relevant disabled persons badge to wait for up to three hours (with a return prohibited within one hour) on the length of roads and sides of lengths of roads specified 'therein'.
- 7.Documents giving more detailed particulars of the Order are available for inspection at the offices of the Engineering Department, Merthyr Tydfil County Borough Council, Unit

20, Merthyr Industrial Park, Pentrebach, Merthyr Tydfil during normal working hours.8.Objections to the Order together

with the grounds on which they are made must be made in writing to the undersigned by 23rd February 2017.
