APPLICATION FOR SEASON TICKET BY DIRECT DEBIT



The cost of an annual car park season ticket is £350. By applying to pay by direct debit you will be able to pay this fee in twelve separate instalments of £29.17 over the year (please note that payments will be taken directly from your nominated bank account on or immediately after the 1st of each month).

Once you have received your season ticket you will be eligible to park in any of the following car parks (*NB You will be exempt from purchasing a parking ticket when a valid season ticket is displayed*).

- Abermorlais Car Park (Saturday Only)
- Castle (S) Car Park (Saturday Only)
- Castle Car Park
- Castle Multi Storey Car Park
- River Taff Car Park
- St Tydfil Car Park
- Pontmorlais Car Park
- Swan Street Car Park (Disabled Only)
- Tramroad (E) Car Park
- Gilar Street Car Park

The majority of the Council's car parks are covered by CCTV, however drivers leaving their vehicle in the car park do so at their own risk.

Please ensure that before leaving your vehicle that it is parked correctly in a marked bay as failure to do so is a penalty of £70.

The Direct Debit Guarantee



- This Guarantee is offered by all Banks and Building Societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit Merthyr Tydfil County Borough Council will notify you 10 working days in advance of your account being debited or otherwise agreed. If you request Merthyr Tydfil County Borough Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by Merthyr Tydfil County Borough Council or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your Bank or Building Society.
 - If you receive a refund you are not entitled to, you must pay it back when Merthyr Tydfil County Borough Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
