#### MERTHYR TYDFIL COUNTY BOROUGH COUNCIL REPLACEMENT LOCAL DEVELOPMENT PLAN (LDP) 2016-2031

As part of the Examination of the Merthyr Tydfil County  
Borough Council (MTCBC) Replacement Local Development  
Plan 2016-2031, the Council has proposed a number of  
Matters Arising Changes (MACs) to the Deposit Plan which  
are considered necessary for soundness.

These changes are outlined in the 'Schedule of Matters  
Arising Changes' document dated September 2019. The  
Matters Arising Changes are subject to a formal 6 week  
consultation between 9<sup>th</sup> September 2019 and midnight on  
21<sup>st</sup> October 2019.

Other supporting background documents, including the  
Sustainability Appraisal Report Addendum (September 2019)  
and Habitats Regulation Assessment (HRA) Appropriate  
Assessment (AA) Addendum (September 2019) will also be  
issued for consultation during this period.

The Replacement LDP will, upon adoption, supersede the  
current LDP which was adopted in 2011 and form the basis  
for decisions on land use planning matters in Merthyr Tydfil  
County Borough (excluding the area within the Brecon  
Beacons National Park).

Representors who consider that the proposed Matters Arising Changes will not make the Plan sound, should clearly explain the reasons why and what changes are required. Representors proposing changes to a Matters Arising Changes should consider the implications on the Sustainability Appraisal. Where proposed changes have significant sustainability effects the representation should include relevant Sustainability Appraisal information.
