April/May 2021



Consultation on revised options for 3-16 Voluntary Aided Catholic school

Residents and other stakeholders are being asked for their views on revised options for Merthyr Tydfil's new single all through 3-16 Voluntary Aided (VA) Catholic school.

Following consultation, the County Borough Council approved in January this year, the land south of the Greenie, west of Galon Uchaf Road as the site for the school development.

Leading schools builder Willmott Dixon Construction was appointed to design and develop the school. The team has carried additional 'scoping work' to meet the Council's aims of presenting an alternative choice for the positioning of the school on the site, addressing concerns that were raised during the initial consultation and the potential to enhance the existing community facilities.

As a result, the two options below are now being put forward:

- Option 1 (a development of the approved option A from the initial consultation in November 2020) – now with all car parking and drop-off facilities on the same side of the road as the school building. There would also be shared use of one of the community playing fields, enhanced to an all-weather facility, and with car parking provided for community access out of school hours.
- Option 2 (an alternative configuration of the whole site) - the school building now being located on the current Greenie playing fields with both playing fields relocated to the southern end of the site. One of the playing fields would be a shared all-weather facility, and the other field would be accessible to the community at all times.

The Council is running a two-week consultation exercise from April 23rd - May 7th

Stakeholder consultation events are also being planned online so that the views of residents, community users of the Greenie playing fields, schools/governors, and other key stakeholders are considered and help inform the decision taken.

The new school is expected to open on the new site in September 2023 and its construction will mean closure of the current Bishop Hedley High School, St Aloysius RC Primary, and the Federation of St Illtyd's and St Mary's RC Primary Schools.

This provision is a partnership between the County Borough Council and the Archdiocese of Cardiff. The Most Reverend George Stack, Archbishop of Cardiff has said *"The new provision will put us in an advantageous position to deliver the new curriculum and give our children the benefits of an uninterrupted journey"* he added. *"it will allow us to continue to build upon the very good education currently offered in a state-of-the-art campus."*

Chief Officer, Learning, Sue Walker said: *"We're asking the community to support us in considering the amended options and choosing the best possible site for the school, the community and all stakeholders."*

PROS

Option 2

OPTION 2

PROS

- School building is set back further from residential properties
- Promotes connection with neighbouring residential areas to north, west and east
- Potential to use existing, safe pedestrian routes into the site from all directions
- Improved facilities for community use will be relocated at the southern end of the existing site
- Elevated position maximises daylight and increases visible presence of the school building within the community.
- Maximises views for surveillance from the school building to the school grounds to the south.
- All parking and drop off located on the same side of road as school and so no pedestrians required to cross Galon Uchaf Road from parked vehicles/drop off.
- One way access/egress onto site will ease congestion if used properly due to long stack lengths / queue length capacity from the Junction.
- Safer access / egress junctions with better visibility
- Intuitive vehicle circulation on site with one way drop-off.
- Passengers alighting on footpath not carriageway
- More efficient use of land for road access/egress and so larger area available for sports and outdoor play facilities circa 3,000m².

CONS

- Requires existing sports pitches, changing areas and small playground to be relocated although existing MUGA is retained.
- Community sports pitches/fields will be located in close proximity to residential properties including floodlight provision on all-weather surface.
- Requires community changing rooms to be relocated or shared use of school changing rooms
- The elevated location means the building will be prominent on site from the surrounding residential areas. This can also be a positive in respect of providing a visible community building.
- Whilst they will be larger than the minimum size required, there is not enough space for 2 nr 100 x 64 m pitches to be provided.
- If the one-way road onto site is abused e.g. stopping without using a parking space, this could cause congestion.

Ymgynghoriad ar opsiynau diwygiedig ar gyfer Ysgol Gatholig Wirfoddol a Gynorthwyr 3-16

Gofynnir am safbwyntiau preswylwyr a rhanndeiliaid eraill ynghydchopsiynau diwygiedig ar gyfer ysgol newydd pob oed 3-16 Gatholig Wirfoddol a Gynorthwyr (GG) i Fferthyr Tudful.

Yn dilyn ymgynghori, cymradwydd y Cyngor Bwrdeistref Sirol ym mis Ionawr eleni, dir i'r de o'r Greenie, sef i'r gorllewin o Heol Galon Lchaf, fel y safle ar gyfer datblygiad yr ysgol.

Penodwyd cwmni adeiladu arweiniol, Willmott Dixon Construction, i ddylunio a datblygu'r ysgol. Gwnaeth y tîm gyflawni 'gwaith cwmpasu' ychwanegol i fodloni nodau'r Cyngor o gyflwyno dewis amgen o ran lleoli'r ysgol ar y safle, gan fynd i'r afael â phryderon a godwyd yn ystod yr ymgynghoriad gwreiddiol a'r potensial i wella'r cyfleusterau cymunedol presennol.

O ganlyniad, mae'r ddau opsiwn isod yn cael eu gosod ger bron:

- Opsiwn 1 (datblygu opsiwn A a gymradwywyd, o'r ymgynghoriad gwreiddiol ym mis Tachwedd 2020) – bellach gyda'r holl barcio ceir a chyfleusterau gollwing ar yr un ochr o'r ffordd ag adeilad yr ysgol. Byddai'r defnydd o un o'r caeau chwarae hefyd yn cael ei rannu a'i wella i fod yn gyfleuster pob tywydd, gyda pharcio ceir wedi ei ddarparu ar gyfer mynediad i'r gymuned y tu allan i oriau ysgol.

- Opsiwn 2 (ffurfweddiad amgen i'r safle cyfan) – lleoli adeilad yr ysgol ar gaeau chwarae cyffredol y Greenie, gyda'r ddau gae chwarae yn cael eu hadleoli i ben deheuol y safle. Byddai un o'r caeau chwarae yn gyfleuster pob tywydd sy'n cael ei rannu, a byddai'r cae arall yn hygyrch i'r gymuned ar bob adeg.

Mae'r Cyngor yn rhedeg ymarfer ymgynghori pythefnos o hyd o Ebrill 23 – 7 Mai.

Disgwylir i'r ysgol newydd agor ar y safle newydd ym mis Medi 2023, a bydd ei hadeiladu yn golygu cau ysgol gyffredol Ysgol Uwchradd Esgob Hedley, Ysgol Gynradd Gatholig Sant Aloysius a Ffederasiwn Ysgolion Cynradd Gatholig Sant Illtyd a'r Santes Fair.
