



Terms and Conditions for the 'Recycling your plastic bags and wrapping' promotion ('the Promotion'):

1. The Promoter of the Promotion is WRAP (The Waste and Resources Action Programme), which is a registered UK Charity (No. 1159512) and whose address is Second Floor, Blenheim Court, 19 George Street, Banbury, Oxon, OX16 5BH.
2. This free prize draw competition is open to residents aged 18 or over and living in a home that was invited to take part in the 12-week 'Recycling your plastic bags and wrapping' trial between Monday 10 May and Friday 30 July 2021. Maximum one entry per property address. Employees of WRAP, Blaenau Gwent County Borough Council, Merthyr Tydfil County Borough Council, or their family members or anyone else connected in any way with the Promotion or helping to set up the Promotion, shall not be permitted to enter.
3. Entry into the Promotion shall constitute deemed acceptance of these terms and conditions so please read them carefully before entering the Promotion.
4. Any personal information you supply by entering the Promotion will be held and processed by the Promotor in accordance with WRAP's Privacy Policy:

5. The Promotion starts on Monday 19 July 2021 at 00:01 (BST) and ends at 23:59 (BST) on Sunday 8 August 2021.
6. Entries must be received after 00:01 (BST) on Monday 19 July 2021 and before 23:59 (BST) on Sunday 8 August 2021. Entries received outside of this time period will not be valid.
7. To enter you must:
  - complete the online survey promoted on your local council's website, noting whether you are a resident of Blaenau Gwent County Borough Council or Merthyr Tydfil Country Borough Council
  - write your email address and postcode on the form where asked.
8. There will be two prize winners who will be selected at random on Monday 9 August 2021 by WRAP from all valid entries. One winner from Blaenau Gwent and one winner from Merthyr Tydfil.
9. The same prize will be awarded to each of the two winners, which is a £50 Love2shop Gift Card.
10. Each winner will be contacted by 16:00 on Wednesday 11 August 2021 via the email address provided by entrants on their submitted survey form.
11. The winners must each provide the Promoter with proof of identity and proof of their home address to establish eligibility before being confirmed as a winner and before delivery of their prize is arranged.
12. If the Promoter does not receive a response from a winner within 72 hours of its first attempt at contact, if the winner rejects their prize, or the drawn entry is subsequently found to be invalid or in breach of these terms and conditions, then the prize will be forfeited and the Promoter shall be entitled to select another winner(s).

13. The prizes will be delivered to the winners at their home address in Blaenau Gwent or Merthyr Tydfil, via a secure 'Signed For'- style postal method, such as 'Royal Mail Signed For'.
14. By entering the Promotion, you give permission for WRAP and your local council to mention your title, surname and town in any communications about the trial's prize draw.
15. The Promoter accepts no responsibility for any costs associated with the prize.
16. The Promoter reserves the right to substitute a prize of the same or higher value should the original prize become unavailable for circumstances beyond its reasonable control. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
17. The Promoter reserves the right at any time, and from time to time, to modify or discontinue, temporarily or permanently, the Promotion with or without prior notice due to reasons outside its control.
18. The Promoter will not be liable for any failed entry attempts whatever the cause.
19. The Promoter accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered as a result of entering the Promotion or accepting the prize. Nothing shall exclude the liability of the Promoter for death or personal injury as a result of its negligence.
